The preparation of financial Statements of Bihar state Educational Infrastructure Development Corporation Limited for the year ended 31 March 2016 in accordance with the financial reporting framework prescribed under the Companies Act, 2013(Act) is the responsibility of the Management of the company. The Statutory Auditors appointed by the Comptroller & Auditor General of India under Section 139(5) of the Companies Act, are responsible for expressing opinion on these Financial Statements under section 143 of the Act based on independent audit in accordance with the standards on auditing prescribed under section 143(10) of the Act. This is stated to have been done by them vide their Audit Report dated 16 September 2016.

I, on behalf of the Comptroller & Auditor General of India, have conducted a supplementary audit section 143(6)(a) of the financial statements of Bihar State Educational Infrastructure Development Corporation Limited for the year ended 31March 2016. Bills pertaining to construction projects amounting to ₹ 1.91 crore have not been accounted for in the same year although received during the period 2015-16.
