· Clause 1 -- All compensation or other sums of money payable by the contractor to Govern-ment under the terms of his contract may be deducted from, or paid by the sale of a sufficient pare his security deposit, or from the interest arising there from or from any sums, which may be due or may become due to the contractor by Government on any account whartsoever and in the event of his security deposit being reduced by reson of any such deduction or sale as afore said, the contractor shall within ten days thereafter make good in cash or Government securities endorsed as aforsaid any sum or sums which may have been deducted from or arised by sale of his security deposit or any part thereof.
