## 4 Instruction to the bidders

#### 4.1 General Terms & Conditions

- a) The Education Department/BSEIDC expects the bidders to adhere to the terms of this Request for Proposal (RFP) and subsequent corrigendum / addendums (if published) and shall not accept any deviations to the same. Under exceptional circumstances, Request for deviations from RFP, if any, can be submitted to Education Department/BSEIDC. The Education Department/BSEIDC reserves its right to accept or reject such deviations from the tender terms.
- b) Agency appointed through this RFP shall be solely responsible for discharging all responsibilities as mentioned in the RFP notwithstanding the fact that the vendor may appoint / procure services of third party suppliers (including software providers) to perform all or part of the obligations. Education Department/BSEIDC shall not enter into any other agreement with any other agency except the vendor as appointed through this RFP.
- c) Unless agreed to specifically by the Education Department/BSEIDC in writing for any changes to the RFP issued, the vendor's queries/ clarifications/ suggestions/ objections etc. would not be incorporated automatically in the RFP document.
- d) Unless expressly overridden by the specific agreement to be entered into between the Education Department/BSEIDC and the vendor, the RFP shall be the governing document for arrangement between the Education Department/BSEIDC and the vendor.
- e) Each bidder can offer one specific solution only. Bidders are not allowed to propose multiple solutions.

## 4.5 Information Ownership

All information processed, stored, or transmitted by Vendor belongs to the Education Department/BSEIDC. By having the responsibility to verify the details of the student, the Vendor does not acquire implicit access rights to the information or rights to redistribute the information. The Vendor understands that civil, criminal, or administrative penalties may apply for failure to protect information appropriately. For this the vendor has to enter into a Non-Disclosure agreement with the Education Department/BSEIDC that all the information on customer data will be protected using appropriate security measures. Any legal issues due to leak or disclosure of information of the citizen's data will be vendor liability and any cost on the issue will be borne by the vendor.

## 4.6 Exit Option


Education Department/BSEIDC reserves the right to cancel the contract in the event one or more of the following event occurs:


#### 4.6.2 INDEMNIFICATION

  - d) Claims by government regulators or agencies for fines, penalties, sanctions or other remedies arising from or in connection with the Second party failure to comply with its regulatory/legal requirements and compliance;
  - e) Any claim on account of an alleged breach of confidentiality and security of data occurring as a result of acts of omissions or commission of the Second party employees or sub contractors;
  - f) Any claim occurring on account of misconduct, negligence or wrongful acts of omission and commission of employees of the Second party, and /or its subcontractors;

# 4.6.4 INDEPENDENT CONTRACTOR

# 4.7 Termination
