In case of such failure in delay in the supply of materials or stores on an application by the continuctor within 30 days form the date of such failure or delay, such extension of time shall be granted to the contractor for completion of the work as shall appears to the Engineer to be reasonable in accordance with the circumstances of the case. The decision of the Executive Engineer as to the extension of time shall be accepted as finally by the contractor.

Action and compensation payable in case of work.

3. The rates quoted by the contractor should be inclusive of all taxes royalties and other

6. The tender without earnest money or insufficient earnest money submitted with the tender, will be outright rejected.
