Compensation

Clause 1:- All compensation or other sums of payable by the contractor Government under the terms of his contract may be deducted from, paid by the sale of sufficient part of his security deposit or from the Interest arising therefore or from any sum which may be due or may become due to the contractor by Government on any accompliated whatsoever and in the event of his security deposit being reduced by reason of any sum deduction or sale as aforesaid, the contractor shall within ten days there after make good cash or Government securities endorsed as aforesaid any sum or sums which may have be deducted from, or arised by, sale of his security deposit of any part thereof

(b) To employ labour paid by the Public Works Department and to supply materials to carry out the work, or any part of the work, debitting the construction with the cost of the labour and the price of the materials (of the amount of which cost and price certificate of the Engineerin -charge shalf be final and conclusive against the contractor), and crediting him with the value of the work done, in all respects in the same manner and at the same rates as if it had been carried out by the contractor under the terms of his contract, the certificate of the Executive Engineer as to the value of the work done shall be final and conclusive against the contractor.
